Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 16.00 crore bank facilities of R.P.M. Engineers (India) Limited (RPM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Chennai based, RPM was established in 1975 as a proprietary concern and converted to private limited in 1997. The company is led by Directors, Mr. Ramprasad Divya, Mr. Mahadevan Ramprasad, Ms. Raji Ramprasad Iyer, Ms. Pavithra Ramprasad and Mr. Niranjana Ramprasad. The day-to-day operations are led by Mr. M Ramprasad (Managing Director) and Mr. R Niranjana (Technical Manager). The company is engaged in manufacturing of dairy equipments and food processing machinery.

Non-cooperation by the issuer/borrower:
