Rating Rationale

Acuité has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) and reaffirmed the short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 16.00 crore bank facilities of R P M Engineers India Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

The Chennai based, R P M Engineers India Limited was established in 1975 as a proprietary concern and converted to private limited in 1997. The company is led by Directors, Mr. Ramprasad Divya, Mr. Mahadevan Ramprasad, Ms. Raji Ramprasad Iyer, Ms. Pavithra Ramprasad and Mr. Niranjan Ramprasad. The day-to-day operations are led by Mr. M Ramprasad (Managing Director) and Mr. R Niranjan (Technical Manager). The company is engaged in manufacturing of dairy equipments and food processing machinery.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
