#### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) on the Rs. 11.50 crore bank facilities of Axi Lam Private Limited (ALPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

#### About the Company

ALPL is an Ahmedabad-based company incorporated in 2015 which is promoted by Ashvinkumar Kantilal Patel, Ganpatbhai Punjabhai Patel, Ashish Jayantilal Patel, Vasantbhai Shankarbhai Patel, Bharatbhai Patel, Shaileshbhai Shivabhai Patel, Ravi Amrutbhai Patel. The company is engaged in the manufacturing of laminated sheets and has an integrated processing plant at Gujarat with an installed capacity of 900,000 units per annum.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
