Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 15.30 crore bank facilities of P&R Gurdittiwala Hydro Power Limited (P&R). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

P&R Gurdittiwala Hydro Power Limited (P&R) was incorporated in 2014 by Ms. Pardeep Kaur and Mr. Jagbir Singh. The company was incorporated as an SPV (Special Purpose Vehicle) to undertake a 2 MW hydropower project in Punjab. Since then, it is engaged in the business of running a hydropower plant on the Ferozpur Canal.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
