Rating Rationale

Acuité has downgraded the long term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 15.30 crore bank facilities of P and R Gurdittiwala Hydro Power Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

P and R Gurdittiwala Hydro Power Limited was incorporated in 2014, by Ms. Pardeep Kaur and Mr. Jagbir Singh. The company was incorporated as an SPV (Special Purpose Vehicle) to undertake a 2 MW hydropower project in Punjab. Since then, it is engaged in the business of running a hydropower plant on the Ferozpur Canal.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/ borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
