Acuité has reviewed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 40.00 crore bank facilities of Aarya Exim (Aarya). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Aarya was established in 2013 by Mr. Harenbhai L. Viradiya and Ms. Savitaben L. Viradiya. The partners possess a decade of experience in the gems and jewellery industry. The firm is engaged in the manufacturing and trading of gold, silver and diamond jewellery.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
