Rating Rationale

Acuite has reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 150.00 Cr bank facilities of Shreyanshu Impex. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Gujarat based, Shreyanshu Impex (SI) was established in 2011 by Mr. Ashwinbhai L. Viradiya and Mr. Harenbhai L. Viradiya. The partners possess a decade of experience in the gems and jewellery industry. The firm manufactures and trades in gold, silver and diamond jewellery. SI imports raw material - diamond, gems, silver among others from Hong Kong, Italy, Malaysia and exports to Singapore, Hong Kong and several European countries.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
