SMERA has reaffirmed the long term rating to '**SMERA BB+**' (**read as SMERA double B plus**) and short term rating to '**SMERA A4+**' (**read as SMERA A4 plus**) to the Rs.23.75 crore bank facilities of Eros Motors Private Limited. This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower: SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

The company, led by Mr. Anuj Pande deals in commercial vehicles, passenger cars and tractors. EMPL is the authorised dealer of Hyundai Motor India Ltd for passenger cars. The company also deals in SML Isuzu's commercial vehicles and Piaggio's three and four-wheelers (light commercial vehicles). Besides, EMPL is an authorised distributor for tractors of Mahindra & Mahindra Ltd in Vidarbha (excluding Nagpur, Yavatmal, Amravati, and Chandrapur).
