Acuité has reviewed the long-term rating of '**ACUITE D** (read as ACUITE D)' on the Rs. 6.10 crore bank facilities of Mission Media Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Mission Media Private Limited (MMPL) was established as a Private Limited Company in 2005 in Chattisgarh by Mr. Sunil Kumar, Mr. Nilay Kumar and Mr. Surendra Kumar is engaged in printing job work, making Ad. films and publishing of local newspaper in Raipur, Chhattisgarh. The company takes printing orders from Maharashtra textbook corporation, Chhattisgarh textbook corporation and Orissa textbook corporations through tenders.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
