Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 44.80 crore bank facilities of Nash Fashion India Limited (NFL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Rajasthan-based, Nash Fashion India Limited (NFL) was incorporated in 1998. The company manufactures ladies readymade garments, grey cotton fabric and finished cotton fabrics. The company generates around 90 per cent of revenue by exporting ladies' readymade garments to Spain, France, Mexico, Argentina and United Kingdom, to name a few. NFL has an annual manufacturing capacity of around 3 million pieces with an average utilisation of 70 per cent. The company's manufacturing facilities are based in Jaipur. The present directors of the company are Mr. Ramesh Chandra Nischal, Mr. Dashrath Singh and Mr. Jai Singh Sethia.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavoured to gather information about the entity/ industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
