Acuite has reviewed the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 2.40 crore bank facilities of S Srinivasan. This rating is now an indicative rating and is based on the best available information.

S Srinivasan, a Tamil Nadu-based proprietary concern was established in 1983 by Mr. S. Srinivasan. The firm is engaged in the trading of paddy, rice and bran.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
