Rating Rationale

Acuite has reaffirmed the long-term rating of 'ACUITE B-' (read as ACUITE B minus) on the Rs. 2.40 crore bank facilities of S Srinivasan. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

S Srinivasan, a Tamil Nadu-based proprietary concern was established in 1983 by Mr. S. Srinivasan. The entity is engaged in the trading of paddy, rice and bran.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
