Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) on the Rs. 11.35 crore bank facilities of Mohijuli Tea Company Private Limited (MTCPL). This rating is now an indicative rating and is based on best available information.

Mohijuli Tea Company Private Limited (MTCPL) was established in 1991 by Mrs. Rumena Rehman, Mr. Nilufar Rehman and Mr. Atikur Rehman. The company is engaged in the processing of black tea and had installed capacity of 15 lakh kg per annum. The manufacturing facility is located at Guwahati (Assam). The tea estate is spread across 450 hectares.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
