Rating Downgraded, Reaffirmed and Issuer not co-operating

Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 5.85 crore bank facilities of Dhiman Industrial Fabricators and Designers (DIFD) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ahmedabad based, Dhiman Industrial Fabricators and Designers is a proprietorship concern promoted by Mr. Rajesh Kumar Dhiman in 2007. The firm undertook steel fabrication work for windmill towers on a job work basis. However, in 2013 the entity ventured into construction of pre-engineered steel buildings (PEB) and components, sheds, windmill towers, storage tanks among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
