Rating Rationale

Acuité has reaffirmed the long-term rating of **‘ACUITE D’ (read as ACUITE D)** on the Rs. 14.00 crore bank facilities of Moidus Medicare Private Limited (MMPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Moidus Medicare Private Limited (MMPL), incorporated in 1990, was promoted by Mr. K. Moidu, Mr. K.M. Ashik, Mr. K. M. Navas. The company runs a super speciality hospital under the name 'National Hospital' with a capacity of 400 beds at Calicut (Kerala).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.
