Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-' (read as ACUITE B minus)** from '**ACUITE B' (read as ACUITE B)** on the Rs. 5.60 crore bank facilities of Prakash Whitegold Ginners Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Based in Wardha, Prakash Whitegold Ginners Private Limited was incorporated in 2012. The company is engaged in the ginning and pressing of cotton. The manufacturing facility is located at Hinghanghat district of Maharashtra. Mr. Pranay Omprakash Dalia and Mr. Prashant Premprakash Dalia are directors of the company.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
