Acuité has reviewed long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 14.66 crore bank facilities of Shree Nakoda Ginning and Pressing Factory (SNGPF). This rating is now an indicative rating and is based on best available information.

Shree Nakoda Ginning & Pressing Factory (SNGPF) was established in 1996. The Madhya Pradesh based partnership firm is engaged in the ginning and pressing of cotton bales and also sells cotton seeds.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.
