Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D)on the Rs. 14.66 crore bank facilities of Shree Nakoda Ginning And Pressing Factory. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Shree Nakoda Ginning and Pressing Factory was established in 1996 by Mr. Anand Doshi. The Madhya Pradesh based partnership firm is engaged in the ginning and pressing of cotton bales and also sells cotton seeds. The installed manufacturing capacity stands at 3,025 cotton bales per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
