Acuité has reviewed the long-term rating of '**ACUITE BBB-**' (**read as ACUITE triple B minus**) on the Rs.29.00 crore bank facilities of Total Packaging Services (TPS). This rating is now an indicative rating and is based on best available information.

TPS is a partnership firm established in 2003 by Mr. Dhirajlal Shah and his nephews, Mr. Haresh Gudhka and Mr. Hitendra Gudhka. The firm is engaged in manufacturing of plastic flexible packaging material. The firm has its manufacturing facility at Dabhel (Gujarat) with an installed capacity of 26400 tonne per annum.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
