Acuite has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 15.50 crore bank facilities of Re-Source World Exim Private Limited (RWEPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Re-source World Exim Private Limited (RWEPL), incorporated in 2012, is a Maharashtra-based company promoted by Mrs. Sharmila Nadkarni. The company is engaged in the manufacturing of readymade garments at Bhiwandi and has installed capacity of 70000 units per month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
