Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs. 10.27 crore bank facilities of Malenadu Planters Coffee Curing Works Private Limited (MPCCWPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Malenadu Planters Coffee Curing Works Private Limited (MPCCWPL) was established in 1971 as a Karnataka based company involved in the processing and curing of coffee. The promoters of the company are Mr. M. S. C. Indavara, Mr. M. Poornesh and Mr. H. D. Rame Gowda who have more than two decades of experience in the coffee processing industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
