Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 11.63 crore bank facilities of Bharat Bio Gas Energy Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Gujarat-based, Bharat Bio Gas Energy Limited (BBEL) was incorporated in 2012 by Mr. Bharat J Patel, Mr. Rushabh Shah and Mr. Sharad Kumar Patel. The company is engaged in the manufacturing of CNG from biomass, biowaste and organic fertilisers.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
