Acuité has reviewed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 15.50 crore bank facilities of Anukool India Private Limited (AIPL). This rating is now an indicative rating and is based on best available information.

AIPL (formerly known as Anukool Aircon Private Limited) was originally set up in 1999 as a proprietorship firm by Mumbai-based, Mr. Sandeep Shenoy. The firm was reconstituted as a private limited company in 2004. AIPL is engaged in providing comprehensive services in designing, system engineering, supply, testing, installation, and commissioning of heating, ventilation, and air-conditioning systems. The company provides air-conditioning solutions such as variable refrigerant volumes, chillers, and ducted splits.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
