Rating Rationale

Acuité has downgraded the long term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 15.50 crore bank facilities of Anukool India Private Limited (AIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Anukool India Private Limited was originally set up in 1999 as a Mumbai based proprietorship firm by Mr. Sandeep Shenoy. The firm was reconstituted as a private limited company in 2004. It is engaged in providing comprehensive services in designing, system engineering, supply, testing, installation, and commissioning of heating, ventilation, and air-conditioning systems. The company provides air-conditioning solutions such as variable refrigerant volumes, chillers, and ducted splits.
