Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs.7.00 crore bank facilities of Malnad Coffee Curing Works (MCCW). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Malnad Coffee Curing Works (MCCW) is located in Chickamagaluru, it is mainly involved in curing, handling and grading of coffee. Constituted as a partnership firm, MCCW is led by Mr. Abdul Kareem and Mr. H. L. Natesh was established in 2012. The management has a prior experience of trading in raw coffee since 2010, after which they have moved into the current business of processing and selling of the same.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
