Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 5.60 crore bank facilities of Nahal Poultry Farm on account of information risk. The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

Punjab-based, Nahal Poultry Farm (NPF) was established in the year 1980 as a proprietorship firm by Mr. Jaswinder Singh. The firm is engaged in the business of trading of eggs and cull birds. The ratings continue to draw comfort from the experienced promoters and moderate financial risk profile. However, the aforementioned strengths are partially offset by the small scale of operation, stretched working capital cycle and highly fragmented in the domestic industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
