#### Rating Rationale

Acuité has withdrawn the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 21.00 crore bank facilities of GL Constructions Private Limited (GLCPL). This rating continues to be an indicative rating and is being withdrawn on account of request received by the client along with No Objection Certificate received from the bank.

GL Construction Private Limited (GLCPL) was incorporated in 1996 by Mr. Narayan Mathreja, Mr. Sunil G. Mathreja, Mr. Viveck Mathreja, Mr. Vishal Mathreja and Mr. Tushar Mathreja. The directors have long experience in the execution of road projects as Class-1 contractor. GLCPL is engaged in the construction and maintenance of roads. The firm undertakes contracts from government, semi-government and private entities. GLCPL has executed projects mainly in Mumbai and Thane region for PWD, MCGM, NMMC, TMC, MMRDA, BARC, among others.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
