Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.5.00 crore bank facilities of Silver Group(SG). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Maharashtra based, Silver Group (SG) was established in 2013 as a partnership firm by Mr. Kiran Sawant, Mr. Ganesh Jadhav and Mr. Shivaji Barne. The firm deals in residential complexes. The portfolio of Silver Group includes 6 projects in the PCMC area 'Silver City', 'Silver 9', 'Silver Satyam', 'Silver Karishma', 'Silver 18', 'Silver Royal' and 'Silver Akshay'.

Non-cooperation by the issuer/borrower:
