Rating Rationale

Acuité has reaffirmed the long-term and short-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 22.50 crore bank facilities of Raymix Concrete India Private Limited (RCIPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Tamil Nadu-based, Raymix Concrete India Private Limited (RCIPL) was established in 2005 by Mr. Antony Francis, Mr. Glastin Raj and Mr. Rajan. The company is engaged in the manufacturing of RMC (ready mix concrete). The company caters to the infrastructure sector and has six plants, each with installed capacity of 3000 cubic metres per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
