**Rating Rationale**

Acuite has reaffirmed the Long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.5.88 Crore bank facilities of Dupon Rubber Private Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

Dupon Rubber Private Limited (DRPL) was established in the year of 2015 by Mr. Suresh Kothari and Mrs Anchal Jain. The company is engaged in the manufacturing of tyre. The manufacturing facility is located in Indore district of Madhya Pradesh.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
