SMERA has reviewed long term rating of '**SMERA BB-** (read as SMERA double B minus) and short term rating of '**SMERA A4+**' (read as SMERA A four plus) on the Rs.13.00 crore bank facilities of Jayant K. Furnishers (JKF). This rating is now an indicative rating and is based on best available information.

Non-cooperation by the issuer/borrower: SMERA has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and SMERA's policies.

About the Rated Entity:

JKF, established in 1981 is a Mumbai-based firm engaged in civil contractor work and also provides interior decoration services. The firm is promoted by Mr. Khimji Ramji Soni, Mr. Narayan Khimji Soni and Mr. Jayanti Khimji Soni.

For FY2015-16, JKF reported net profit of Rs.3.77 crore on operating income of Rs.34.27 crore as against net profit of Rs.1.87 crore on operating income of Rs.34.27 in the previous year. The net worth stood at Rs.10.19 crore as on March 31, 2016 as against Rs.11.25 crore in the previous year.

Any other information: SMERA is yet to receive the latest No Default Statement (NDS) from the rated entity, despite repeated requests and follow-ups.
