

Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 13.00 crore bank facilities of Jayant K Furnishers on acount of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

Jayant K Furnishers was established in 1981, is a Mumbai based firm engaged in civil contractor work and also provides interior decoration services. The firm is promoted by Mr. Khimji Soni, Mr. Narayan Khimji Soni and Mr. Jayanti Khimji Soni.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
