Acuité has downgraded the long term rating to '**ACUITE BB**' (**read as ACUITE double B**) from '**ACUITE BB+**' (**read as ACUITE double B plus**) on the Rs.25.00 crore bank facilities of Siwan Tractors Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

STPL, was set up as a proprietorship concern in 1982, and later reconstituted as a private limited company in 2005. It is an authorized dealer of passenger and light commercial vehicles of Mahindra & Mahindra Limited, and a distributor and dealer of tractors of Escorts Limited in Siwan and Gopalganj (both in Bihar).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
