### Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+ (read as ACUITE B plus)**' on the Rs. 10.00 crore bank facilities of Apkon Crushers (AC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

Apkon Crushers (AC) is a Karnataka-based proprietorship firm promoted by Mrs. Asha Prasanna Kumra, Mr. B.N. Prasanna Kumar and Mr. Vikram Bavikatte in 1992, and it was later converted into a partnership firm in 2008. The firm is engaged in the crushing of white -grey metal stone and manufacturing of sand and stone jelly.

### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

### Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
