Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B Plus) on the Rs. 10.76 crore bank facilities of Vardhman Spinners on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperatina" and is based on best available information.

About the Company

Vardhman Spinners was established in 2008, it is a Panipat based partnership firm promoted by Partners, Mr. Ajay Kumar Jain, Mr. Hemant Jain, Ms. Dipti Jain, and Ms. Shashi Jain. The firm is engaged in the manufacturing of blankets and has an installed capacity of 1.10 lakh blankets per month. The firm procures raw material, i.e. cotton yarn from Haryana, Punjab, Uttar Pradesh and Delhi and sells blankets across India under the 'Vardhman' name.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
