## Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs.9.10 crore bank facilities of Silver Global Services Pvt. Ltd. (SGS). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

# **About the Company**

SGS was established in 1998 as a proprietorship concern by Mr. Alphonso D'Souza. Later in 2008, reconstituted as a private limited company with other directors including Mrs. Stella D'Souza (his wife), Mr. Kevin D'Souza (his son) and Mr. Rolan D'Costa (his son-in-law). SGS is engaged in handling, cleaning, testing and maintenance of liquid carrying tank containers. The business is managed by Mr. Rolan D'Costa. The service depot facility is located at Mumbai.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
