Rating Rationale

Acuite has reaffirmed the long term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs. 9.60 crore bank facilities of Kamla Rice & General Mills (KRG M). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Kamla Rice & General Mills, established in 1994, is a Karnal-based proprietorship concern. The proprietor, Mr. Vipin Goel, has extensive experience in the rice milling business. The firm is engaged in the milling and processing of basmati and non-basmati rice and has an installed capacity of 1920 ton rice per month. The firm sells its products under the ‘Good wish’ brand name.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
