Acuité has reviewed long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs.11.25 crore bank facilities of Krishna Tunga Agro Industries (KTAI).

Non-cooperation by the issuer/borrower: Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

About the Rated Entity:

KTAI, established in November 2013, is a Karnataka-based firm engaged in the manufacturing and processing of food grains, pulses among others. The firm is headed by Mr. B. Prasad.

For FY2014-15, KTAI reported net profit after tax of Rs.0.24 crore on total income of Rs.38.23 crore as against a net loss of Rs.0.43 crore on total income of Rs.9.66 crore a year earlier. The net worth stood at Rs.5.35 crore as on March 31, 2015, as compared with Rs.4.04 crore a year earlier.
