#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.00 crore bank facilities of Mittal Engineering Works (MEW) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information

#### **About the Company**

Mittal Engineering Works (MEW) was established in 1989 as a partnership firm by Mr. Laxminarayan Agarwal, Mr. Devichand Agarwal and Mrs. Bharpadevi Agarwal. Later in 2000, Mr. Mukesh Mittal joined as a partner. The firm started off by manufacturing sheet metal components. From 2011, it began the manufacture of ERW tubes that contributed around 70 per cent to total sales and the balance 30 per cent from sheet metal components. The firm has a manufacturing unit with two tube mills at Chakan in Pune (Maharashtra).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
