Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 9.96 crore bank facilities of Sanjivini Pipes And Fittings Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Karnataka based, Sanjivini Pipes And Fittings Private Limited is a private limited company incorporated in 2012. It is promoted by Mr. Mohammadali, Mr. Prashanth Ananda Kunder, Mr. Badruddin Abdulla Navunda, Mr. Rakshith Kunder and Mr. Navunda Hamza. It is engaged in manufacturing PVC pipes and fittings. The company operations are based out of Udupi, Karnataka. The manufactured products are mainly used in agricultural activities. The company mainly imports raw materials from South Korea and Japan. The Company only caters to domestic regions. The raw materials required for the manufacture of PVC pipes are PVC resins.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
