Acuité has reviewed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) and short term rating of '**ACUITE A4**' (**read as ACUITE A four**) on the Rs. 12.00 crore bank facilities of Su Solartech Systems Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Chandigarh-based, Su Solar Tech Systems Private Limited (SSPL) was incorporated in 1985 by Mr. Harinder Jain and Mrs. Santosh Rani Jain. The company is engaged in the manufacturing of solar photovoltaic lighting systems, solar thermal water heating systems and solar PV wind hybrid power generation systems.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
