Rating Rationale

Aucité has reaffirmed the long-term rating of ‘**ACUITE D’ (read as ACUITE D)** and short term rating of ‘**ACUITE D’ (read as ACUITE D)** on the Rs. 16.00 crore bank facilities of Aarti Suitings Private Limited (ASPL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Aarti Suitings Private Limited (ASPL) was established in 1994 by Mr. Nand Kishore Jindal, Mr. Madhur Jindal and Ms. Nidhi Jindal. The company is engaged in the manufacturing and export of suiting, shirting and fabrics at Bhilwara, Rajasthan.

Non-cooperation by the issuer/borrower:

Aucité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Aucité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Aucité’s policies.
