Acuité has reviewed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.15.00 crore bank facilities of Shiv Shakti Rice Mills (SSRM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Punjab-based, Shiv Shakti Rice Mills (SSRM) was established in the year 2008 as a partnership firm by Mr. Vikas Bansal, Mrs. Krishna Devi and Mr. Rajnish Kumar. The firm is engaged in the business of milling and processing of basmati rice with the installed capacity of 5 tonnes per hour.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
