Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE D' (read as ACUITE D)**' and the short-term rating of '**ACUITE D' (read as ACUITE D)**' on the Rs. 11.00 crore bank facilities of Piscesia Power Transmission Private Limited (PPTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Uttar Pradesh based Piscesia Power Transmission Private Limited (PPTPL) was incorporated in 2012 and is currently managed by Mr. Prashant Sharma, Ms. Vandana Yadav and Mr. Euy Don Park. The company is engaged in the business of execution of turnkey projects for setting up power transmission substations and underground cabling for Uttar Pradesh Power Transmission Corporation Limited (UPPTCL).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
