Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 24.50 crore bank facilities of KBC Infrastructures Private Limited (KIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 2007, KIPL is an Andhra Pradesh based company promoted by Mr. Butuchaiah Kannegati and Mrs. Vasavilatha Kanneganti engaged in civil construction work. The company is engaged in the construction of roads and bridges for government organizations' Andhra Pradesh (AP) Roads & Buildings Department and Panchayet Raj Department.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
