Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-' (read as ACUITE B minus)** on the Rs. 6.50 crore bank facilities of Arcedges Building India LLP (ABI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Arcedges Building India LLP (ABI) was incorporated in 2016 by Mr. Saurabh Shah, Mr. Ashok Shah, Mr. Sureshchandra Dudani and Mr. Dipesh Dudani. The firm is a steel infrastructure solutions company that manufactures pre-engineered structures and is also into the fabrication of metal at Ahmedabad. It plans to set-up a manufacturing facility with a capacity of 15000 MTPA for structured steel products. ABI, established in 2016 is expected to commence commercial operations from April 2017

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit ratings is based.
