Rating Rationale

Acuite has downgraded the long term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.70 crore bank facilities of Aerotherm Products (AP) on account of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

Ahmedabad based Aerotherm Products (AP) was established in 1986 by Mr. Ashutosh Shukla, is engaged in the business of design and manufacture of heat and air transfer equipment. The firm is involved in the design, develop, manufacture and erection of capital engineering equipment primarily used in processing industries such as refineries, fertilizer plants, rayon and fabric industry, pharmaceutical industry, and other core and basic industries.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
