Ratina Rationale

Acuité has downgraded the long term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 90.00 crore bank facilities of R.Krishnamurthy & Co on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

R.Krishnamurthy & Co, a proprietorship concern established in 1991, was converted into a partnership firm in 2008. The firm is engaged in the civil construction business and caters to the governments of Tamil Nadu and Pondicherry. The partners, Mr. Krishnamurthy R and Mr. Jamunarani K, possess extensive experience in the industry. The day-to-day operations are led by Mr. Krishnamurthy R. The registered office of the company is in Chennai.

Non-cooperation by the issuer/borrower:
