Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 7.00 crore bank facilities of Rajasthan Polytex Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Rajasthan Polytex Private Limited, incorporated in 1988, is a Surat-based company promoted by Mr. Madan Periwal, Mrs. Ramadevi Periwal and Mr. Priyesh Kumar Periwal. It is engaged in the manufacturing and trading of cotton fabric. The company has an installed capacity of 65 lakhs meter per annum.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
