#### Rating Rationale

Acuite has withdrawn the long term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs.11.50 Cr. bank facilities of Shri Saraswati Trading Company (SSTC). The rating continuous to be flagged as an 'Issuer Not-Cooperating' based on best available information.

The rating is being withdrawn on account of the request received from the company and the NOC received from the banker as per Acuite's policy on withdrawal of ratings.

#### About the Entity

The Uttar Pradesh based, SRM is a partnership firm promoted by Mrs. Adesh Garg, Mrs. Saroj Garg and Mr. Amit Garg. It was established in 1998 for processing of paddy. The concern trades and processes basmati rice in the domestic market.

Shri Saraswati Trading Company (SSTC) is a Punjab based proprietorship firm established in 2012 by Ms. Seema Rani. The firm is engaged in the trading of basmati and non-basmatirice, paddy, rice husk, rice bran. The firm purchases paddy and rice (basmati and non-basmati both) from suppliers in Punjab and sells the same to clients across Punjab, Haryana, Uttar Pradesh and Rajasthan.

#### Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
